Find the 22 Garden Grove Freeway, it runs between the 605 and 55, East and West through Orange, Santa Ana, Garden Grove, Westminster, Los Al, and Seal Beach.


Exit Beach Blvd. South (toward the ocean), and turn right (West) on Trask Ave. The 2<sup>nd</sup> street on your left going south is Richardson Way. Proceed down Richardson Way, through the dog leg at 24<sup>th</sup> street and in about 5 blocks, you'll find 13791 on your right side of the street.

If you go past Trask on Beach, make a right turn (West) on 21<sup>st</sup> Street and proceed about 3 blocks to Richardson Way. Turn left or south onto Richardson Way and 13791 should be right near the intersection with 20<sup>th</sup> St.

DIRECTIONS FROM THE 405: Go North on Beach Blvd until you go past Westminster Ave. Then get in the far left lane and turn left or west onto 21st Street. Go about 3 blocks and turn left or south on Richardson Way. 13791 should be on your right near the intersection with 20th Street.

I just wish we had met him sooner. Headquarters sent the family a sympathy resolution.

We lost another member, Mr. James
Farmer who flat out resigned. He also
resigned his service in the Richmond
Howitzers reenactment company. Another
member who always renews late has failed
to reply back to me after several attempts.
He never attended meetings, but he always
talked strongly about our purpose and the
need to continue the things we do. Unless
someone speaks to us, we don't know where
the problem is or why they stop
communicating.

Scott Mills the Ph.D. student who interviewed us for his graduate work on memory and who introduced us to his wife has not renewed. He was dealing with a new family and relocating to Spring Valley, CA. He did tell me the check was in the mail, and I sent him a note back saying I never received a check.

Determined people don't loose focus. Men like us know our place, we know our history, and we stand up for what we believe to be true and important. We read, we learn and never give up. We are strong and stronger by the friends we keep. God will vindicate, he is on our side and sees our mission and purpose as good and meaningful.

Then we have one member who about a month ago blamed his wife for not writing the check. I still haven't received his dues check.

I'm so proud of our members who have stood strong and continued their memberships every year. Our organization is a life long commitment based upon our genealogy, our history. We cannot change history, we cannot make claim to a different family line. We are who we are and we should proud to be a part of something so important, so symbolic in the development of this country.

## MINUTES SCV ~ MEETING ~ OCT. 21<sup>ST</sup>, 2012 CAMP 1770 | ORANGE COUNTY, CALIFORNIA

- 1. This meeting was held at the home of Cmdr. Cooley. We began with a welcome of our newest member, Steven Knowles, and his wife Denise.
- 2. Rev. Daniel Fuson led us in prayer for the Invocation.
- 3. We conducted our protocol processes of Pledge of Allegiance; Salute to the Confederate Flag; and the reading of the Charge by Gen. Stephen D. Lee.
- 4. Next, we indulged in a pot luck luncheon with Fried Chicken as the main dish. Steven Frogue brought his famous baked beans, Ray Evans brought his garden salad, Mr., and Mrs. Fuson brought homemade macaroni salad and homemade applesauce. Our most recent member, Philip Forbes brought devil eggs and Mr. and Mrs. Hasha brought a pie as did Mr. and Mrs. Knowles who brought 2 pies. We also had Ice Cream for those who wanted it. This turned out to be a wonderful meal with plenty to eat for everyone. Excuse me if I forgot to mention someone who brought a dish.
- 5. Our first order of business was to initiate our newest member, Steven Knowles. Congratulations to Steven for joining the SCV. Welcome aboard!
- 6. The Adjutant reported on the financial health of the camp, gave an update of how many members have renewed and the next requirement of paying our National dues to headquarters, and the California Division.
- 7. Our genealogist, John Hasha mentioned that he was still working on our camp notebook which will include facts and data accumulated on our Confederate Veterans of Orange County.
- 8. Our Heritage Defense Officer, Scott Price presented to us the petition he drafted to the MOC in Appomattox, VA. All of us signed the petition and he was to mail it to their facility following the meeting. In addition to this, Scott talked to us about the history involved with the MOC, and discussed our recent boycott of Johnny Reb's Restaurant in Orange. No one received a response from Johnny Reb's for their letters written on behalf of our heritage and the message they are sending by removing the 1<sup>st</sup> National Flag from inside their restaurant. The point being, how can they be proud of their name and what they claim to be while backing down to a complaint about our Historic and important flag that represents the Southern man, soldier and society.
- 9. Steven Frogue gave a short presentation on some books he recently picked up. One in particular was a 1<sup>st</sup> edition from 1913 on the WBTS. Though it was fragile, he passed it around

for everyone to examine. He also had 2 other books, one by Bruce Canton that he shared with us.

- 10. We discussed old business such as the JROTC program. Rev. Daniel Fuson gave a report on Savanna High School's position, which has changed over the years to one that, is politically correct. However, Daniel gave us hope in that he had a few more ideas and schools to contact.
- 11. We mentioned as old business our event at Huntington Beach and how little success we achieve in actual memberships after investing 2 days worth of time and energy. On the positive side of this event, we donate \$50 to the H.B. Historical Society, and we educate many people who would otherwise not understand our organization and/or our position of historical facts.
- 12. Starting new business, we mentioned our canned food drive kicked off for this meeting and we received a few canned goods already. Our next event will be Veteran's Day at the monument, and we encourage everyone to bring a canned food item to contribute to our food drive for the homeless. We also made plans for our Christmas Party on Dec. 9<sup>th</sup>, 1:00 pm at Rev. Daniel Fuson's home on the patio, (he has a nice covered patio).
- 13. Don't forget that for our Christmas party, we collect gifts in the amount you feel comfortable with, but we recommend not more than \$20. These gifts are for the Orangewood Children's Home of Orange, where they provide care and housing for children who fall under the jurisdiction of the courts. These children range in age from new born up to 18 years of age. They can use most anything, such as clothing, sports equipment, and toys.
- 14. Don't forget to bring a canned food item so we can continue our food drive for the homeless. We will continue to collect canned food for Veteran's Day, Christmas, and Lee/Jackson Day and our March meeting. After the March meeting, either myself or one of our officers will make the trip to the Orange County Mission located in the city of Tustin. The Mission does a wonderful job of educating and caring for homeless and unfortunate people who need help.
- 15. After we discussed our new business, Rev. Daniel Fuson spoke to us about the Chaplain's in the Confederacy. This presentation was educational and interesting. The Chaplain's of the Confederacy started the WBTS in an awful position without pay, uniform, or weapon. Yet, many of them felt a duty to stay with the regiments and over time began to receive some acknowledgment from the military; such as payment. Most of them were not expected to fight in the front, but a few insisted and actually carried arms and fought alongside the soldiers. Times were tough back then.
- 16. Before we dismissed, I showed a brief clip from the 1938 Gettysburg Reunion, where our Confederate Veterans stood and shook hands with the Yankee Veterans over the stone wall where Pickett's charge came to an end. These veterans were very elderly with long white beards, canes, and wheelchairs.
- 17. Cmdr. Cooley conducted a free raffle to our members for showing their support and attending today's meeting. The first place winner was Ray Evans who chose a bottle of "Rebel Yell" whiskey. The second place winner was Denise Knowles, the wife of our newest member and she got the "Moonshine Cherries." Everyone was delighted to have a chance at winning.

- 16. We adjourned the meeting with a benediction from Rev. Daniel Fuson.
- 17. Thanks to everyone who attended, we had 12 people in attendance. It was also an honor to have our Division Lt. Cmdr. and Cmdr. of Camp 1742, Mr. John Smoley join us for this meeting.
